The PARTICIPANT, for and in consideration of Wolf Branch School District No.113's (ADISTRICT@) agreement to allow PARTICIPANT to use DISTRICT facilities for the ACTIVITY indicated above, and as a condition to PARTICIPANT(S) use of DISTRICT facilities for the ACTIVITY indicated above, hereby agrees to the following terms and conditions:

1. PARTICIPANT hereby releases DISTRICT, its officers, officials, agents, employees, representatives and servants, (both individually and collectively), from and against any and all claims for any injury (including death), costs, damages and/or losses arising out of or otherwise incidental to PARTICIPANT(S) participation in the ACTIVITY. PARTICIPANT agrees to assume the full risk of any such injury, cost, damage or loss PARTICIPANT may sustain as a result of participating in the ACTIVITY.
2. PARTICIPANT has chosen voluntarily to participate in the ACTIVITY and assumes all risks of injury or other damage associated with the ACTIVITY. PARTICIPANT, her or his heirs, executors, administrators, and assigns, hereby releases, waives and relinquishes DISTRICT, its officers, officials, agents, employees, representatives and servants, from and against any and all actions, causes, damages, claims, or demands of every kind, whether known or unknown, arising out of or otherwise incidental to PARTICIPANT(S) participation in the ACTIVITY.
3. PARTICIPANT agrees to indemnify, hold harmless, and defend DISTRICT, its officers, officials, agents, employees, representatives and servants, from and against any and all liability or claims for loss, damage, or injury to person or property, or of any other kind, whether known or unknown, including the PARTICIPANT(S) person and property and including claims for attorneys' fees, arising out of or otherwise incidental to PARTICIPANT(S) participation in ACTIVITY.
4. PARTICIPANT agrees to obey all rules, regulations, and policies, including policies adopted by DISTRICT, while participating in the ACTIVITY. PARTICIPANT agrees that her/his violation of the above rules, regulations, laws or policies (as determined in the sole discretion of any DISTRICT representative), may result in PARTICIPANT(S) immediate exclusion from the ACTIVITY.
5. PARTICIPANT represents that he/she has individual medical insurance coverage that would address any injury or other medical incident that could occur while PARTICIPANT undertakes the ACTIVITY, and that PARTICIPANT will not seek or authorize any redress, offset or other charge against DISTRICT or DISTRICT'S insurance provider(s) with respect to PARTICIPANTS involvement in the ACTIVITY.

This release constitutes the entire agreement between the PARTICIPANT and DISTRICT relating to PARTICIPANT(S) participation in the ACTIVITY. PARTICIPANT agrees that if any part of this Agreement and Release is held invalid, the invalid part will not affect other parts of this Agreement and Release which can be given effect without the invalid part. PARTICIPANT represents that she/he is executing this agreement voluntarily and without any reservation.

This Agreement and Release shall be construed in accordance with the laws of the State of Illinois.
